NEW BUSINESS:

- Good Sam State Meeting Clyde Wickham The Good Sam funds are being depleted at about \$5000.00 per year due to the rent at
 the Lodi Grape Festival fair grounds in Lodi. Good Sam is looking for another place to
 have the Samboree but it will be difficult. Good Sam has supplies, a trailer with
 supplies stored on the grounds and they are not charging storage fees. The Grounds
 gives us a discount on the Rent of \$1000. It would be 3 times that. Because of the
 attendance of only 17 chapters out of 34 revenue is down considerably.
- Good Sam is raising the Rig membership fee for the chapters to belong to Good Sam from \$3.00 to \$5.00. Keep in mind; these fees are paid out of our chapter funds.
- The theme for 2016 Samboree will "Down on the Farm"... There will be Tables for the Saturday night dinner that the Chapters may decorate with the Chapter Logo. A 12" X 12" center square in the middle of the table will be allotted for the decoration.

The Rig Membership fee to Good Sam was discussed. To keep the revenue in our treasury up – we raised our dues \$5.00, from \$25.00 to \$30.00.

A motion was made to raise the membership dues for the chapter \$5.00. That would make the dues per member be \$30.00. Jack C. made the motion. Seconded by Vanessa M. The Motion carried, the dues will be \$30.00 for 2016 and beyond. The Dues are due and payable by December 1, 2015 and delinquent December 31, 2015 for 2016 year.
